The Meeting of the Clinton Township Board of Trustees was held on Wednesday, October 5th 2016 at 999 Chambers Rd. Present were Trustees John Coneglio, and Jane Cera, Fiscal Officer Deb Steele, Fire Chief Fraley, Police Chief Jones, Superintendent of Roads Dan Klopfenstein, Township Manager Skip Apple, Code Enforcement Officer Kyle Whalen, and many residents. Chair and Trustee Carl Reardon was unable to attend the meeting.

GENERAL

Res. No. 16-10-012 Motion by Trustee Cera to approve the agenda with flexibility. 2nd Trustee Coneglio. Vote: Trustee Coneglio – Yes, Trustee Cera –Yes

There was a presentation from Brain Carter who is the existing manager of the township's approximately \$1.6M investment portfolio. Mr. Carter has worked with the township going back to the year 2006 and only works with government investment accounts, a specialized type of investment banker. He reviewed that the township grew about 1% last year and is set to do slightly better in 2016 growing by about \$15,000.00. Mr. Carter shared his business card with the Board and a few residents. After he left the Fiscal Officer stated that she has reviewed investment proposals from a total of 3 banks and is suggesting the township invest in Government Bonds over the near future. Trustee Cera suggested the Fiscal Officer provide the Board with an overview of the 3 proposals.

There was a presentation by Caroline Asebrook from Toole & Associates about the administration of reviewing plans for the Building Department.

There was discussion about a 457 plan with a company called Security Benefit. It is similar to Ohio Deferred Compensation but managed by the company Security Benefit. Two individuals in the Fire Dept. are utilizing this plan.

Trustee Cera pulled together a meeting with administrators and the company that made the Township's website. There was a snag with the slow speed of the township's internet during the training. Updates will continue; most recently pictures from the two Open House events have been posted.

TOWNSHIP MANAGER

There was a review of 3 paving proposals for re-paving the parking lot at 999 Chambers. One proposal was too high and the remaining two proposals are both about \$43K. There is some slight differences such as thickness of pavement between the two and maybe adding extra asphalt for more entrances to the building. The Fire Chief just spoke with the Township Manager about the proposals and they will work together to revise the scope of work needed.
