Present were Trustees Jane Cera, Carl Reardon, and Aliena Sword, Fiscal Officer Deb Steele, Township Administrator Vaughn, Fire Chief Fraley, Superintendent of Roads Villa, and Code Enforcement Officer Whalen.

GENERAL

Next meeting will be on the Eastside at 3820 Cleveland Ave on September 5^{th,} at 7pm. This will be the first meeting in the new building.

There was discussion about Amending the 2018 Permanent Appropriations. A new line item was created in the general fund for an annual TWP Admin car allowance. The Fire and EMS 599 "other" line items would receive an additional \$50,000 each. Not all the resources for Fire and EMS had been appropriated for the year yet.

NEW BUSINESS

Resident Bobbie Olt presented an estimate of the Fiscal Officer working 12 hours a week and if she worked this or less, the Fiscal Officer would be making more per hour than the Police or Fire Chief. Ms. Olt explained that when she was the Fiscal Officer she had to do payroll but Ms. Olt does not think an Assistant is needed currently in the Fiscal Office because payroll is outsourced. Fiscal Officer Steele stated she works more than 12 hours a week. Ms. Olt and resident Jane Magiotta said they do not think that is true and they do not support an Assistant in the Fiscal Office. Fiscal Officer Steele again reminded everyone that theft is more likely when only one person is running finances. Trustee Sword stated that she supports another set of eyes on fiscal items. Ms. Olt replied that she thought that is something the Township Administrator should be able to do. Resident Nick Gani is seeking a 5 year plan per Department, with salaries listed. Mr. Gani is concerned about the reduction in CEDA/JEDZ revenues. Trustee Reardon stated he wanted more of a presence in the Fiscal Office during business hours. Trustee Cera stated that she had called some Franklin County Townships of similar operating budget size as Clinton, and that it is not at all unusual to have fiscal and administrative assistants. Resident Carol Stuart looked into the law and confirmed the Fiscal Officer is allowed to work from home. Ms. Stuart asked her neighbors to look at other options rather than always voicing the same negative concerns in meetings.

Ms. Stuart also requested the shark teeth be repainted on speedbumps because they are hard to see.

Resident Nick Gani stated that he has two estimates to clear trees at Chamber Cir. They are about \$2,500 to \$3000. There is a desire to extend the shelter house on one side. Ms. Stuart shared a product that could be attached to the shelter house to provide more cover. It is from a company called Bring Covers in Cleveland and she has reviewed this with Administrator Vaughn.

Resident Jane Magiotta is upset because she sees all the money coming from the West Side but all the services seem to be on the East Side.

Trustee Cera stated that she did not understand this constant animosity of some west side residents, she has been actively attending events on the West Side and has supported every item proposed for additional services and the sidewalk addition along Kinnear Rd.
