The Meeting of the Clinton Township Board of Trustees was held on December 19th, 7pm at 999 Chambers Rd. Present were Trustees Jane Cera, Carl Reardon, and Aliena Sword, Fiscal Officer Deb Steele, Township Administrator Vaughn, Fire Chief Fraley, Police Chief Jones, Superintendent of Roads Villa, and residents.

Fiscal Officer Steele read the November 2018 Fiscal Report. On October 1st there was an overall Fund Balance of \$6,371,562.04 there was \$279,965.89 in Revenue and \$862,050.61 in Expenditures leaving an overall Fund Balance of \$5,789,477.32 on November 30th, 2018.

Resident Jane Margiotta brought a copy of the recent Township newsletter that was mailed out to residences. She circled typo mistakes she found. Township Administrator Vaughn stated this was done under his supervision and was aware of the mistakes, and he apologized for the errors. Ms. Margiotta stated that she is appalled this happened.

Resident Bobbie Olt asked when the roof at 999 Chambers would be complete. There was a lot of activity and then she has not seen the construction workers as much. Township Administrator Vaughn replied that the project is 98% complete.

Resident and Employee of the Road's Dept Bill Margiotta asked why there has not been another person hired into the Road's Dept. Trustee Cera stated that the Board has not yet had a motion brought forward internally to ask the Board to consider adding to the Road Dept. He elaborated that he had recently been ill and he felt it was difficult to be sure all the needed work was getting done. The Trustees reviewed staffing levels over the recent years including that the Roads Department had recently effectively run with one fewer crew for about 3 years.

Fire Chief Fraley thanked everyone for their efforts at the recently Holiday Parade. It was the 70th annual Holiday Parade for the Township. Despite the rain everyone who participated had a good time.
